**ORDER RE SUPPLEMENTAL
NOTICE OF CLASS ACTION
SETTLEMENT**

1 Pursuant to the hearings held on July 31, 2014, August 7, 2014, and August 8,
2 2014, and having considered the submissions and arguments of counsel, the Court
3 hereby orders as follows:

4 1. The Parties shall cause supplemental notice to be sent to those class
5 members who have previously received notice but who have not yet submitted a
6 claim form or requested exclusion. The supplemental notice, claim form, and
7 envelope shall be substantially in the form of the documents previously submitted as
8 Docket #273-1, #273-2, and #273-3.

9 2. The Parties shall cause Notice Packets to be sent to the approximately
10 548 individuals who have been identified as members of the class who have not yet
11 received notice. These Notice Packets, including the applicable notice and claim
12 forms, shall be in the same form as those originally sent to class members, as
13 proposed in Docket #273-4, #273-5, and #273-6.

14 3. Defendant C.R. England shall also provide a notice through its
15 electronic messaging system to class members stating that:

16 “The claim-filing deadline in the Jasper class action settlement has been
17 extended until October 9, 2014. If you have not done so already, you may fill
18 out a claim form on-line at www.JaspervCREngland.com. The website also
19 provides contact information in the event that you lost your claim form, claim
20 number, or pin code.”

21 4. The Administrator may contact class members via telephone who have
22 not submitted a claim form to verify whether the class members have received the
23 notices regarding the settlement. The Administrator may not solicit the filing of
24 claim forms, but may provide information regarding the applicable deadline and
25 procedures and, if asked questions, may refer class members to Class Counsel for
26 further information.

27 5. Counsel for the *Campbell* Objectors, Swartz Swidler, LLC, may obtain
28 and submit claim forms, which may be electronically signed, on behalf of any class

1 members who have submitted a Consent Form to join the collective action in the
 2 *Campbell et al. v. C.R. England*, District of Utah, Case No. 2:13-cv-00262. Claim
 3 forms for class members who previously received Notice Packets but who are
 4 receiving a supplemental notice because they had not yet submitted a claim may be
 5 submitted by Counsel for the *Campbell* Objectors using the supplemental postcard
 6 claim form submitted as Docket #273-2. Claim forms for any of the approximately
 7 548 class members who are being sent Notice Packets for the first time must be
 8 submitted using the claim form submitted as Docket #273-5 or 273-6.

9 6. The following schedule shall apply to the supplemental notice and
 10 continued final approval hearing.
